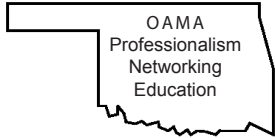

HOW TO REGISTER:

Registration is considered confirmation to attend. No telephone registrations will be accepted. If you require special accomodation, please notify OML no later than Friday, September 1.*

CANCELLATION POLICY:

HOTEL ACCOMMODATIONS:

If you require overnight accommodations for Wednesday, September 13, please contact the DoubleTree Hotel, 616 W. 7th Street, Tulsa, OK 74127, (918) 587-8000 or the Aloft Hotel, 200 Civic Center, Tulsa, OK 74103, (918) 947-8200. The Aloft is a brand new hotel located immediately east of the Cox Business Center and across the street from the Doubletree Hotel Downtown.

Directions from the Hotel Staff:

From Airport: Hwy 11 East to 75 South. Exit at 7th St and turn right continue 7 blocks. Hotel is on the left, between Denver and Houston. Transportation - Complimentary van shuttle available 5am-11pm. Shuttle runs every hour on the hour with prior arrangements. Shuttle service not wheelchair accessible.

General Arrival Directions: South or North - From I-75, take the downtown 7th St exit. This takes you directly to the hotel at 616 West 7th St. East or West- From I-244, connects with I-75. Then take downtown 7th St exit. 8 blocks on left.

From I-64/51 (Also known as Broken Arrow expressway)- Take the Houston St exit. At the traffic light, make a right onto Houston St. Take Houston one block, make a right onto 7th St. The hotel entrance on the right. From I-40- I-40 connects to Highway 75. Take 75 N to 64/51 E. Take the 13th and Denver exit. Take a left on Denver, then a left on 7th. Follow 7th until you see the hotel on the left.

From Oklahoma City: Take Turner Turnpike and continue towards Downtown Tulsa. Since there is construction, the 7th street exit is not there but there is an exit going east off the highway. Take that onto hwy 51 and get over to the right of the highway because you will exit to the right immediately on Denver. As you exit, turn left then left again at the stoplight. Take Denver west to 7th street and turn left again-the hotel will be on you left, it is about a block from the corner where you turn.
