### **IMMEDIATE ACTION NEEDED – MUNICIPAL VOICES NEED TO BE HEARD**

**SB1465** by Sen. James Leewright (R) Bristow is scheduled to be heard **Monday, February 12, at 10:30 a.m.** This bill prohibits any political subdivision from restricting, taxing, prohibiting or issuing any ordinance regulating the use, disposition or sale of auxiliary containers. Auxiliary container means any bag, cup, package, container, bottle or other packaging that is made of cloth, paper, plastic, including foamed or expanded plastic, cardboard, corrugated material, aluminum, glass, post-consumer recycled material or similar material including, but not limited to, coated or laminated materials.
