**PREEMPTION BILLS ARE DEAD THIS SESSION**

Yesterday marked the deadline to hear bills from the opposite House of Origin. Bills that were not heard by adjournment are dead for this Session. Of those bills that died were bills that OML opposed and worked to make sure they never saw the light of the dome. Two of them were as follows:

**SB 1465** by Sen. James Leewright (R-Bristow) and Rep. Tim Downing (R-Pauls Valley) would have prohibited any political subdivision from restricting, taxing, prohibiting or issuing any ordinance regulating the use, disposition or sale of auxiliary containers. Auxiliary container means any bag, cup, package, container, bottle or other packaging that is made of cloth, paper, plastic, including foamed or expanded plastic, cardboard, corrugated material, aluminum, glass, post-consumer recycled material or similar material including, but not limited to, coated or laminated materials.

OML was up against the State Chamber and several lobbyists as we worked to assure this bill was not given a hearing. Thank you for reaching out to your Representatives and asking them to vote NO on SB 1465. It helped us conquer this bill!

**SB 1374** by Sen. Jason Smalley (R-Stroud) and Rep. Josh Cockroft (R-Tecumseh) created the preemption for dockless bikes. The bill would have prohibited any political subdivision from imposing a tax on, or require a license for, a bicycle sharing company for the provision of bicycle rental and use or subject a bicycle sharing company to the political subdivision's requirements for rates, entry, operational or other requirements. This bill was also on the House agenda but never heard on the House floor.

**GOVERNOR VETOES E-FAIRNESS BILL**

On Wednesday, Governor Mary Fallin **vetoed SB 337** by Sen. Tom Dugger (R-Stillwater) and Rep. Greg Babinec (R-Cushing) stating that it was duplicative of HB 1019xx which was passed and signed into law during Special Session a few weeks ago. SB 337 required out-of-state vendors making sales of tangible personal property for use in this state that does not collect use tax to file an annual statement with the Tax Commission. The statement for each purchaser must show the total amount paid for Oklahoma purchases during the preceding

to file shall subject the retailer or vendor to a penalty of \$10 for each purchaser unless they show reasonable cause of such failure.

Fallin stated in her veto message that "HB1019XX provides for remote sellers that had sales within this state of at least \$10,000 within the last 12 months to make an election to either file an annual statement with the Oklahoma Tax Commission of Oklahoma purchases made during the preceding calendar year for each customer or collect and remit the tax on sales into the state. No similar provision is contained in SB0337. The Tax Commission has reported a positive response from remote sellers with the provisions of HB1019XX already passed by this Legislature for collecting and remitting the tax on sales into the state. Those collections would not only include the state tax but the tax for our cities and counties as well."

### **BILLS ON THE MOVE**

Here is a snapshot of bills impacting cities and towns.

**Jails/Pregnant Inmates:** [HB 3393](#) by Rep. Ben Loring (D-Miami), Rep. Chris Kannady (R-OKC), and Sen. A J Griffin (R-Guthrie) creates new law regulating penal institutions, detention centers and county jails requiring the least restrictive restraints necessary when the facility has actual or constructive knowledge that an inmate is pregnant. The bill contains comprehensive details.

The House rejected the Senate amendments and has requested further conference.

**Pension Actuarial Analysis/Benefit Increase:** [HB 2985](#) by Rep. Avery Frix (R-Muskogee) amends the Oklahoma Pension Legislation Actuarial Analysis Act by altering the definition of a non-fiscal retirement bill. A non-fiscal retirement bill means a retirement bill which does not affect the cost or funding factors of a retirement system or which affects such factors only in a manner which does not grant a benefit increase under the retirement system. This bill adds an exception for "cost-of-living adjustments provided to retirees of the retirement system". New law in the bill grants a 4% increase in retirement benefits to the Oklahoma Firefighter and Police Pension Systems as well as other state pension systems including the Oklahoma Public Employees Retirement System. Volunteer firefighters receiving benefits via 11 O.S. Section 49-101 shall receive a benefit equal to \$7.83 for each year of credited service not to exceed 30 years.

A motion was made to suspend Joint Rules for the purpose of allowing immediate consideration. The motion failed.

**Law Enforcement/Fine:** [SB 1203](#) by Sen. Anthony Sykes (R-Moore) and Rep. Dustin Roberts (R-Durant) amends 47 O.S. Section 11-801 by altering speeding fines/costs for offenses in subsection B or F. For 1 to 10 miles per hour over the speed limit for offenses occurring prior to November 1, 2022 the fine is \$5 with costs and fees not be exceed \$95. The money is then divided in new law to various entities/purposes such as the District Attorney, Sheriff, Attorney General, CLEET and the like. For an offense occurring on or after November 1, 2022 for 1 to 10 miles per hour over the limit the fine is \$10.

The bill advanced off the House floor by a vote of 86-0.

**Firearms/Unlawful Carry:** [HB 2527](#) by Rep. Bobby Cleveland (R-Slaughterville) and Sen. Nathan Dahm (R-Broken Arrow) amends unlawful carry by adding county employees when acting in the scope of employment within the courthouses of the county.

The bill advanced off the Senate floor by a vote of 34-5.

**Law Enforcement/Controlled Dangerous Substances:** [HB 2796](#) by Rep. Tim Downing (R-Purcell) and Sen. A J Griffin (R-Guthrie) amends the Uniform Controlled Dangerous Substances Act at 63 O.S. Section 2-302. It impacts persons who manufacture, distributes, dispense, prescribe, administers or uses for scientific purposes any controlled dangerous substances within "or into" this state. There are registration requirements and confidentiality mandates with exceptions for certain peace officers. The bill contains details.

The bill advanced off the Senate floor with the title restored by a vote of 39-1.

**Municipal Court/Procedure:** [SB 689](#) by Sen. Greg Treat (R-OKC) and Rep. Terry O'Donnell (R-Catoosa) is a detailed bill exceeding 65 pages amending various statutes in Title 22. Included are changes to the Oklahoma Community Sentencing Act impacting Court of Criminal Appeals implementation of rules for establishing payment plans of fines, costs, fees and assessments by indigents, risk and needs assessments, court procedures, intervention programs, sentencing considerations, suspended sentences, deferred judgments and the like. The bill contains details.

The bill advanced off the House floor with the Conference Committee Report adopted by a vote of 76-13.

**County Jails/Maximum Capacity:** [SB 1442](#) by Sen. Eddie Fields (R-Wynona), Sen. Kimberly David (R-

Porter) and Tim Downing (R-Purcell) amends 57 O.S. Section 37 removing time frame requirements and language regarding receiving inmates by a penal facility from a county jail.

The bill advanced off the House floor by a vote of 78-14.

**Post-Conviction Act/Forensic Evidence:** [SB 1464](#) by Sen. Anthony Sykes (R-Moore) and Rep. Tim Downing (R-Purcell) amends 22 O.S. Section 1080 by adding forensic scientific evidence that was not available to be offered by a defendant at trial or that disputes forensic scientific evidence relied on by the state at trial. The bill advanced off the House floor by a vote of 92-0.

**School Surplus Property/Housing Authority:** [HB 1334](#) by Rep. Chuck Hoskin (D-Vinita) and Sen. John Sparks (D-Norman) amends 70 O.S. Section 5-117 adding housing authorities to the entities eligible to receive surplus school property without consideration.

The bill advanced off the Senate floor by a vote of 36-3.

**Pension/Actuarial Analysis Act:** [HB 1340](#) by Rep. Randy McDaniel (R-Edmond) and Sen. Greg Treat (R-OKC) amends the Oklahoma Pension Legislation Actuarial Analysis Act by adding to the definition of a non-fiscal bill. Added is a provision for a one-time increase in retirement benefits if the increase in retirement benefits is not a permanent increase in the gross annual retirement benefit payable to a member or beneficiary, occurs only once pursuant to a single statutory authorization and does not exceed four (4) alternative benefit increases/funded ratios. The retirement benefits increase in the alternatives if higher funded ratios are maintained. As an example, included is the lesser of 2% of the gross annual retirement benefit of the member or \$1,000 if the funded ratio of the affected retirement system would not be less than 60% but not greater than 80% after the benefit increase is paid. New law defines "funded ratio" including that the rate of return on public retirement system assets for computation of the funded ratio shall not exceed 7.5% but shall be computed using any assumed rate of return utilized by the applicable retirement system if such rate or return does not exceed 7.5%. Effective October 1, 2018, a public retirement system shall make a one-time distribution, consistent with one of the four above alternative benefit increases/funded ratios, to retired members who have retired for a period of 5 or more years. In addition, new law recites the need for retiree benefit increases since the last authorization in 2008, and the modification of a non-fiscal bill is a prudent response to the needs of retirees and is consistent with obligations for prudent and conservative management.

The bill passed the Senate by a vote of 33-3.

**Juveniles/Court Records:** [SB 224](#) by Sen. A J Griffin (R-Guthrie) and Rep. Chris Kannady (R-OKC) amends various sections of Title 10A regarding the confidentiality of youthful offender court records.

The bill has been enrolled with the House amendments adopted.

**Sales Tax Exemption/Expansion:** [SB 906](#) by Sen. Frank Simpson (R-Ardmore) and Rep. Tommy Hardin (R-Madill) expands the disabled veterans sales tax exemption by excluding the sale of a motor vehicle from the current annual limit of sales not to exceed \$25,000. The bill has been placed in the Senate General Conference Committee on Appropriations.

**Condemnation/Section Line Roads:** [SB 1377](#) by Sen. John Sparks (D-Norman) and Rep. Avery Frix (R-Muskogee) amends 69 O.S. Section 646 regarding the county commissioner's authority over section line roads involving a proposal to vacate. The bill contains details.

The bill has been placed in the House Conference Committee on Transportation.

**Law Enforcement/Burglary:** [SB 786](#) by Sen. Greg Treat (R-OKC) and Rep. Ben Loring (D-Miami) amends the definition and penalty for burglary. In addition, new law creates penalty for breaking into any coin-operated or vending machine or device.

The bill passed the House with the second Conference Committee Report adopted by a vote of 56-33.

**Affordable Housing Act/Tax Credit:** [SB 953](#) by Sen. A J Griffin (R-Guthrie) and Rep. Kevin Wallace (R-Wellston) modifies the Oklahoma Affordable Housing Act. Any unused credit in a taxable year "which begins on or after January 1, 2019," may be carried forward to each of the next "two (2)" subsequent taxable years. Current law's carryforward is five (5) years.

The bill advanced off the House floor with the title and enacting clause stricken by a vote of 95-2.

**County Clerk/Record Fees:** [SB 1043](#) by Sen. Paul Rosino (R-OKC) and Rep. Lewis Moore (R-Arcadia) amends 19 O.S. Section 245 regarding county clerk's duty to provide records on request. The current fee is per "page". The bill substitutes per "image".

The bill advanced off the House floor with the title stricken by a vote of 91-5.

**Law Enforcement/Controlled Dangerous Substances:** [SB 1185](#) by Sen. Lonnie Paxton (R-Tuttle) and Rep. Jon Echols (R-OKC) amends the Uniform Controlled Dangerous Substances Act by altering the definition of marijuana creating the Oklahoma Industrial Hemp Agricultural Pilot Program Act.

The bill advanced off the House floor by a vote of 91-5.

**CLEET/Basic Peace Officer:** [SB 1023](#) by Sen. Greg McCortney (R-Ada) and Rep. Todd Thomsen (R-Ada) authorizes CLEET to conduct full-time Basic Peace Officer Certification Academies and other law enforcement relate training for individuals not commissioned or appointed by a law enforcement agency.

The bill advanced off the House floor by a vote of 86-0.

**Law Enforcement/Abuse:** [SB 1150](#) by Sen. A J Griffin (R-Guthrie) and Rep. Zack Taylor (R-Seminole) creates new law requiring school officers or employees or members of a board of education to notify law enforcement of any verbal threat or act of threatening behavior which reasonably may have the potential to endanger students, school personnel or school property. In addition, a school employee who has reason to believe that a student is a victim of abuse or neglect shall report the matter promptly to DHS and local law enforcement. The bill contains details.

The bill and its emergency clause passed the House by a vote of 80-0.

**Workers' Compensation/Affidavit of Exempt Status:** [SB 1249](#) by Sen. James Leewright (R-Bristow) and Rep. Glen Mulready (R-Tulsa) amends the Workers' Compensation Act regarding sub-contractors and altering the details of current law's Affidavit of Exempt Status.

The bill advanced off the House floor by a vote of 64-10.

**Tag Agents/Location:** [SB 1439](#) by Sen. Mike Schulz (R-Altus) and Rep. Chares McCall (R-Atoka) removes the population limits for the location of motor license agencies in 47 O.S. Section 1140. The removed language includes counties with a population of less than 130,000 and municipalities having a population of less than 8,500 located in a county having a population of greater than 130,000. In addition, a population limit is placed on a motor license agency being the primary source of income for the agent. For this to apply, the county must have a population in excess of 30,000 persons. The bill contains details.

The bill advanced off the House floor by a vote of 76-18.

**Occupational License/Preemption:** [SB 1475](#) by Sen. Adam Pugh (R-Edmond) and Rep. Mike Osburn (R-Edmond) known as the Occupational Licensing Review Act creates the Occupational Licensing Advisory Commission. The Commission shall review each occupational or professional licensing act in this state. Included is a public meeting with a vote to determine whether to recommend to the Legislature that a license be maintained, modified, or repealed. A report is given to the Governor and legislative leaders and placed on the Department of Labor website. Forms may be developed for consistent evaluation and review of licenses, permits and the like which may be issued by a state regulatory authority, or required by law or rule, before a person may lawfully engage in a particular occupation, profession, trade or business.

The bill and its emergency clause passed the House by a vote of 81-7.

**Law Enforcement/DNA Collection:** [HB 3439](#) by Rep. Carol Bush (R-Tulsa) and Sen. Wayne Shaw (R-Grove) amends DNA testing requirements in 20 O.S. Section 1313.2. Impacted are Rapid DNA analysis and fee collection. If an individual that is arrested or convicted submits a DNA sample to an arresting authority, jail or booking center for Rapid DNA analysis, the individual shall pay the agency processing the sample a fee of \$150 in lieu of the DNA fee. Collection is the responsibility of the agency conducting the Rapid DNA analysis. The fee shall be used to pay the expenses incurred to perform the Rapid DNA analysis. In addition, 74 O.S. Section 150.27a is amended creating the OSBI Criminalistics Services Division (CSD) to make rules on collection, "storage", "analysis", expungement and dissemination of information and samples for the OSBI CODIS Database. Duties are specified for the CSD including the use of Rapid DNA systems for law enforcement. The bill contains details.

The bill passed the Senate with the title and enacting clause restored by a vote of 36-5.

**Law Enforcement/Human Trafficking:** [SB 1005](#) by Sen. A J Griffin (R-Guthrie) and Rep. Chris Kannady (R-OKC) amends human trafficking by creating a law enforcement duty for "any peace officer or employee of a district court" to assume protective custody over a minor. The duty is triggered if the officer has a reasonable suspicion that a minor may be a victim of human trafficking and is in need of immediate protection. The bill contains details including required emergency social services including medical examination/treatment or a mental health assessment.



The bill has been enrolled with the House amendments adopted.

**Open Records Act/Court Clerk:** [SB 1346](#) by Sen. Paul Scott (R-Duncan) and Rep. Rande Worthen (R-Lawton) amends 22 O.S. Section 977 regarding court records of convictions. The court must include a notation in a copy of the judgment of the defendant's "month and" year of birth "date". The court shall also obtain this data.

The bill has been enrolled with the House amendments adopted.

**Roofing Contractor Registration Act/Labor Only Crews:** [SB 1535](#) by Sen. A J Griffin (R-Guthrie) and Rep. Mike Osburn (R-Edmond) amends the Roofing Contractor Registration Act by adding a definition of "labor only crews" and "prefabricated or pre-engineered metal building erector" and altering the definition of "residential roofing contractor work". Metal building erectors who install prefabricated-or pre-engineered-metal-building packages and labor only crews are then included in the section of those exempted from the Act. The bill contains details.

The bill and its emergency clause have been enrolled.

**Wind Energy/Military Bases:** [SB 1576](#) by Sen. Mike Schulz (R-Altus) and Rep. Charles Ortega (R-Altus) amends 17 O.S. Section 160.20 to protect the operation of any military installation or branch of the military regarding proposed wind energy facilities or proposed wind energy facility expansion. These facilities shall not encroach or otherwise have a significant adverse impact on missions, training or operations. No wind energy facility may be constructed or expanded unless an active Determination of No Hazard from the FAA or an approved mitigation plan is obtained from the Military Aviation and Installation Assurance Siting Clearinghouse. These are filed with the Corporation Commission which is authorized to make rules. Amendments are made to 17 O.S. Section 160.21 regarding notification of intent to build a facility which must also be submitted to the Oklahoma Strategic Military Planning Commission. The bill contains details.

The bill and its emergency clause have been enrolled with the House amendments adopted.

**Rural Physicians/Physician Assistant:** [HB 2987](#) by Sen. Mike Schulz (R-Altus) and Rep. Charles Ortega (R-Altus) amends the Physician Manpower Training Commission adding physician assistants to the educational loan repayment assistance of the Oklahoma Medical Loan Repayment Program. Removed from current law is the authority to pay stipends to residents in

exchange for a commitment to serve in rural or underserved areas. The maximum rural population criteria of 7,500 or less may be waived by the Commission. The Commission is given rulemaking authority.

The bill passed the Senate and further conference has been requested.

**Utility Relocation/Rights-of-Way:** [SB 86](#) by Sen. Kimberly David (R-Porter) and Rep. George Faught (R-Muskogee) amends 69 O.S. Section 1205. The new language provides: "for all new construction of state highways that have a primary purpose of bypassing municipalities, the Department shall conduct an economic impact study on the affected municipalities. The study shall be conducted in addition to any study required by state or federal law. Upon completion of the study the impact shall be delivered to the governing bodies of the municipalities. Only upon a written official letter of support formally approved by the municipal governing body from the majority of the affected municipalities, shall the construction project be added to the Department's Eight-Year Construction Work Plan".

The bill and its emergency clause passed the House by a vote of 68-19.

**Electric Power/Tax Credits:** [SB 888](#) by Sen. Josh Brecheen (R-Coalgate) and Rep. Jeff Coody (R-Grandfield) amends 68 O.S. Section 2357.32A by providing that no refund of unused credits, via this subsection, for electricity generated by wind shall be authorized for tax years beginning on or after January 1, 2019.

The bill advanced off the House floor by a vote of 51-46.

**Firearms/Unlawful Carry:** [SB 1212](#) by Sen. Nathan Dahm (R-Broken Arrow) and Rep. Sean Roberts (R-Hominy) adds "wildlife refuge, wildlife management area" to area designated by a municipality in the exception section for concealed carry prohibition.

The bill advanced off the House floor by a vote of 59-28.

**CIB/Code Inspectors:** [SB 693](#) by Sen. A J Griffin (R-Guthrie) and Rep. John Jordan (R-Yukon) amends the Oklahoma Inspectors Act in a number of ways. Included is changing the definition of "building and construction inspector", "inactive building and construction inspector", "report writer" and "authorized agent". Alterations are made to applicants for certification, license and renewal and authorized provider regulation.

The bill advanced off the House floor by a vote of 89-0.

### **BILLS MOVE TO THE GOVERNOR'S DESK**

**Law Enforcement/Sex Offenders:** [HB 3330](#) by Rep. Mike Sanders (R-Kingfisher) and Sen. A J Griffin (R-Guthrie) amends the Sex Offenders Registration Act by changing the residency restriction to add family child care homes.

The bill advanced off the House floor by a vote of 41-0.

**Bail Bonds/Charges:** [SB 1251](#) by Sen. James Leewright (R-Bristow) and Rep. Josh West (R-Grove) amends 59 O.S. Sections 1327 and 1332 regarding the bond being exonerated by operation of law in which the defendant has new or additional charges.

The bill advanced off the House floor by a vote of 52-37.

**Workers' Compensation:** [HB 2722](#) by Rep. Todd Russ (R-Cordell) and Sen. Mark Allen (R-Spiro) amends Workers' Compensation by altering the definition of employee.

The bill advanced off the Senate floor by a vote of 40-0.

**Firearms/Self Defense Act:** [HB 2889](#) by Rep. Zack Taylor (R-Seminole) and Sen. Paul Scott (R-Duncan) amends applications for a handgun license with the sheriff authorized to charge a fee for taking fingerprints.

The bill advanced off the Senate floor by a vote of 39-0.

**Law Enforcement/Stalking:** [HB 3260](#) by Rep. Mark McBride (R-Moore) and Sen. Anthony Sykes (R-Moore) amends the definition of stalking in 21 O.S. Section 1173 by adding a definition of "following" to include a GPS device or other monitoring device. The bill contains details.

The bill and its emergency clause passed the Senate by a vote of 40-0.

**Occupational License/ Pardon and Parole Board:** [HB 2286](#) by Rep. Terry O'Donnell (R-Catoosa) and Sen. Greg Treat (R-OKC) is a bill running over 85 pages impacting various areas of law. Included in Section 16 is a prohibition for a "licensing board" to deny, suspend or revoke an occupational license or certificate for the sole purpose that the applicant has previously been convicted of a crime subject to the certificate of rehabilitation created in the bill. A licensing board includes a municipality that issues a license.

The bill advanced off the Senate floor with the Conference Committee Report adopted by a vote of 40-0.

**Drug Courts/Regulations:** [HB 2881](#) by Rep. Josh West (R-Grove) and Sen. Greg Treat (R-OKC) amends the Oklahoma Drug Court Act in a variety of ways. Included are changes to eligibility requirements and review and process of an offender for a drug court program.

The bill advanced off the Senate floor with the enacting clause restored by a vote of 40-0.

**Crimes/Misdemeanors:** [HB 2281](#) by Rep. Terry O'Donnell (R-Catoosa) and Sen. Greg Treat (R-OKC) is a comprehensive bill of 20 sections amending a variety of criminal statutes creating misdemeanors. Included is embezzlement, falsely personating another, bogus checks, forged or counterfeited promissory note/check and the like, possession of a forged or counterfeited instrument, finding lost property with knowledge of true owner, larceny of merchandise held for sale in retail or wholesale establishments and selling or pledging property to a pawnbroker using false or altered identification. The bill contains details.

The bill passed with the Conference Committee Report adopted by a vote of 40-0.

### **BILLS SIGNED BY THE GOVERNOR**

**DUI/Enhanced Punishment:** [HB 2643](#) by Rep. Dustin Roberts (R-Durant) and Sen. Greg Treat (R-OKC) amends 47 O.S. Section 11-902 removing current language regarding the district attorney seeking to enhance punishment.

**Firearms/Unlawful Carry:** [HB 3353](#) by Rep. Sean Roberts (R-Hominy) and Sen. Nathan Dahm (R-Broken Arrow) amends unlawful carry of firearms to remove "billy" from current law's prohibition and exclude a "wildlife refuge or wildlife management area". In addition, a person with a valid handgun license is authorized to carry such concealed or unconcealed handgun while "scouting as it relates to hunting or fishing". Current law says "bow" hunting.

**Jail/Inspections:** [HB 1461](#) by Rep. Greg Babinec (R-Cushing) and Sen. Paul Rosino (R-OKC) amends jail inspections in 74 O.S. Section 192 removing references to the American Correctional Association Standards, substituting "detention officer" for jailer and amending current law on inspection reports including closure of a deficient facility.

**Fire Protection District/Withdrawal:** [HB 2581](#) by Rep. Mark Lepak (R-Claremore) and Sen. Marty Quinn (R-Claremore) amends 19 O.S. Section 901.23 regarding who can withdraw from a Fire Protection District. In

current law requires 51% of homeowners with one (1) acre or less. The bill removes one acre and substitutes three (3) acres or less.

**Taxation/Notice of Elections/Settlement:** [HB 3156](#) by Rep. Earl Sears (R-Bartlesville) and Sen. Roger Thompson (R-Okemah) amends 11 O.S. Section 16-103.1 by removing the current requirement that municipalities send to the Oklahoma Tax Commission notice of biennial town meeting or resolution calling for its regular municipal elections. Under the bill, municipalities would still send the notice to the county treasurer. In addition, the Tax Commission is authorized to settle a tax controversy in which the liability exceeds \$25,000. Current law is \$10,000. Changes are also made to seizure of cigarettes or tobacco products.

**Pawnshop/Penalties:** [HB 3070](#) by Rep. Rande Worthen (R-Lawton) and Sen. Greg Treat (R-OKC) amends the Oklahoma Pawnshop Act by creating penalties for selling or pledging property to a pawnbroker who uses false or altered identification.

**Boiler and Pressure Vessel Safety Act/Inspections:** [HB 3151](#) by Rep. Jeff Coody (R-Grandfield) and Sen. Lonnie Paxton (R-Tuttle) amends 40 O.S. Section 141.9 impacting the Boiler and Pressure Vessel Safety Act regarding inspections conducted incidental to issuance or renewal of boiler and machine insurance.

**Jails/Housing:** [HB 3470](#) by Rep. John Jordan (R-Yukon) and Sen. Lonnie Paxton (R-Tuttle) amends 19 O.S. Section 180.43 regarding the county sheriff contracting with federal and state entities and municipalities for the feeding, care, housing and upkeep of prisoners, or alien detainees incarcerated in the county jail. Funds from these contracts shall be deposited in the "Sheriff's Service Fee Account". Funds may be expended for "capital expenditures".

**Occupational License/Military Training:** [SB 1141](#) by Sen. J.J. Dossett (D-Sperry) and Rep. Chris Kannady (R-OKC) amends 59 O.S. Sections 4100.4 and 4100.5 to require any state licensing or certification authority to implement rules or laws for recognizing appropriate military training and experience for its occupational or professional licensing or certification process.
